Title: Homeowner Rehabilitation

I. Introduction and Background

The purpose of this document is to provide interested parties with information to enable them to prepare and submit a proposal and to inform them of basic requirements that the County uses as part of its standard contract process. *Your proposal should include the completed Dane County Application for 2010 CDBG and HOME Funds and information requested in Section III below.*

Standard contract requirements concerning Affirmative Action, the Americans with Disabilities Act, the County's Living Wage ordinance, contract termination and modification, etc. are included in the County's boilerplate contract. Contracts with the CDBG/HOME Programs limit administrative costs/expenses to a 10% ceiling.

II. Scope of the Project

A. Project Description:

Dane County is seeking providers for homeowner rehabilitation program(s) designed to improve the condition of the existing owner-occupied housing stock in Dane County. Projects under this program may focus on energy efficiency improvements, health and safety or code-related repairs, accessibility improvements when done in conjunction with code-related repairs, or a combination of the above. Assistance may be offered in the form of a grant or a 0%, deferred payment loan. CDBG and/or HOME funds may be used for these programs. Units assisted with HOME funds must require a minimum of \$1,000 in repairs. All work must be completed in compliance with the Dane County CDBG and HOME Program Rehabilitation Standards.

Please refer to the CDBG Minor Repair Assistance -- Grant Program Standards, and the CDBG Housing Rehabilitation -- Deferred Payment Loans Program Standards for further details regarding program requirements.

B. Objectives:

To improve the condition of existing owner-occupied housing stock in Dane County.

C. Needs/Expectations:

1. Projects must benefit low-and-moderate income persons in the participating municipalities of the Dane County Urban County Consortium.
2. It is expected that projects will meet documented community needs. This includes needs identified: as part of the 2009 Community Survey, as part of the interview process with participating municipalities in the Dane County Consortium, and/or through other "hard" data sources.

3. It is expected that all or a portion of the funds will be targeted to areas of greatest need.
4. If applying for funding under the HOME program, the applicant must demonstrate how the 25% matching funds requirement would be met.
5. All work must be done in compliance with the CDBG – HOME Program Rehabilitation Standards.
6. Services are to be provided in a cost effective manner with measurable performance outcomes.

D. Current Operations:

In 2009 Project Home will be receiving CDBG funding to operate both a major rehabilitation program and minor repair program.

- E. Maximum funding available for this project is 30% of the total HOME Investment Partnerships entitlement grant funds and up to 30% of the Community Development Block Grant grant funds awarded in the year. Based on 2008 Entitlement funding, 30% of the HOME allocation would be approximately \$168,600. For the CDBG program, this falls under the area of Housing programs to which 30% is expected to be allocated across all priorities falling into this category. Based on 2008 Entitlement funds, 30% of the allocation would be \$337,653 spread across all housing priorities.

The County reserves the right to reject any and all proposals and to negotiate the terms of the contract, including the award amount, with the selected proposer prior to entering into a contract. If contract negotiations cannot be concluded successfully with the highest scoring proposer, the County may negotiate a contract with the next highest scoring proposer.

Outcomes (Consolidated Application, Program Description, p. 6, G.)	10%
Experience and qualifications (Consolidated Application, Organizational Profile, pp. 9-13)	15%
Program budget and Matching Funds (Consolidated Application, Project Description, pp. 7-8, Appendix A and B.)	20%
Past Performance (If previously funded, ability to meet timelines and goals in a reasonable fashion, compliance with prior contracts. Maximum points will be awarded to new applicants.)	10%
